

Crutches To Haiti Website Terms of Use

General

Crutches To Haiti, Inc. (“Crutches To Haiti”) welcomes you to our website (“the Crutches To Haiti Website”). The Crutches To Haiti website comprises discussion forums, blogs, data portals, document and information sharing, tools, download areas, and updates hosted by Crutches To Haiti. The purpose of the Crutches To Haiti website is to provide an information and communication resource for interested donors and donation centers for relief goods to go to Haiti, to exchange information and build communities of donation centers.

User’s Acceptance of Terms of Use

These Terms of Use shall govern your access, visits, and participation in the Crutches To Haiti Website. By using, visiting, or registering for a Crutches To Haiti Website account, you are subject to the Terms of Use. If you do not agree to all the Terms of Use, you should not access, visit or participate in the Crutches To Haiti Website. Crutches To Haiti may occasionally change, modify, or update these Terms of Use at its sole discretion. When we post changes to the Terms of Use we will revise the “last updated” date at the top of the statement. You will be deemed made aware of, and will be subject to, the changes to the Terms of Use after the changes have been posted. No change shall apply to a party if there is a legal dispute of which Crutches To Haiti had actual notice on the date of the change.

Registration

Some features of the Crutches To Haiti Website may require you to register or open an account. If you wish to use these features you must provide current, accurate, and complete information about yourself during the registration process. You may also be asked to choose a password and a user name. You are responsible for maintaining the confidentiality of your Crutches To Haiti Website password and account, and assume all liabilities and responsibilities for any and all activities that occur under your account. You agree to notify Crutches To Haiti immediately of any unauthorized use of your account or any other breach of security.
